- (1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) On December 31, 2013, the Reporting Person contributed 230,634 shares of Class B Common Stock to THHC, L.L.C. in exchange for membership interests in THHC, L.L.C. No cash consideration was paid in connection with the contribution. The contribution of shares of Class B Common Stock by the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Accordingly, immediately following the contribution, the shares remain shares of Class B Common Stock.

Member of 10% owner group. John A. Miller serves as trustee of the Reporting Person and has investment power over the shares.
