## Extraordinary General Meeting

LONDON, UK, 9 March 2006 - SkyePharma PLC (LSE: SKP; Nasdaq: SKYE) announces the results of the Meeting held today. The resolution considered by the meeting was the appointment of Mr Robert Th **rejected** by a significant proportion of both votes and number of shareholders.

**The resolution to appoint Mr Thian as a director was defeated by a majority of 28.5 million share**

For the resolution: 225,843,014 votes (880 shareholders)  
Against the resolution: 254,377,799 votes (2984 shareholders)

In terms of votes cast, 53% of votes were against the resolution and 47% were for the re  
shareholders voting, 23% voted for the resolution and 77% against.

Dr Jerry Karabelas, SkyePharma's Non-Executive Chairman, said: "The EGM is now behind us. We ca
