Unilever NV announces that on 22 June 2007 it purchased 438,613 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.410 and euro 22.560 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 7,227 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 75,661,411 Unilever NV ordinary shares in treasury, and has 1,639,066,289 Unilever NV ordinary shares in issue (excluding treasury shares).
