Unilever NV also announces that 52,557 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 81,440,327 Unilever NV ordinary shares in treasury, and has 1,633,287,373 Unilever NV ordinary shares in issue (excluding treasury shares).
