Unilever NV also announces that 1,197,758 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 114,958,432 Unilever NV ordinary shares in treasury and has 1,599,769,268 ordinary NV shares in circulation.
