(1) The reporting person was granted 8,000 restricted stock units ("RSUs") under Kirkland's 2002 Equity Incentive Plan. Restricted stock units vest in full three years after the date of the grant.

These stock options were issued under the Company's Amended & Restated 2002 Equity Incentive Plan and will become exercisable as to (2) 25% of the underlying shares on the first anniversary of the grant dates and thereafter will become exercisable as to 6.25% of the underlying shares per quarter for the subsequent three years.
