**CHIPMOS REPORTS REVENUE FOR AUGUST 2004**

**Hsinchu, Taiwan, September 17, 2004** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (Nasdaq: IMOS) today reported unaudited consolidated revenue for the month of August 2004.

Revenue for the month of August 2004 was US\$39 million or NT\$1,329 million, an increase of 65% from US\$24 million or NT\$804 million for the same period in 2003 and an increase of 3% from US\$38 million or NT\$1,289 million for the month of July 2004. (The above numbers were based on an exchange rate of NT\$34.05 against US\$1.00 as of August 31, 2004.)

ChipMOS's consolidated revenue for the month of August 2004 includes revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS Far East Limited, ChipMOS LOGIC TECHNOLOGIES INC., CHANTEK ELECTRONIC CO., LTD., Modern Mind Technology Limited and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., and ThaiLin Semiconductor Corp..
