ChipMOS REPORTS REVENUE FOR MARCH 2005

Hsinchu, Taiwan, April 19, 2005 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of March 2005.

Revenue for the month of March 2005 was NT\$1,199.6 million or US\$38.0 million, an increase of 16% from NT\$1,032.6 million or US\$32.7 million for the month of February 2005 and an increase of 5% from NT\$1,139.5 million or US\$36.1 million for the same period in 2004. (All translations from NT dollars to US dollars were made at the exchange rate of NT\$ 31.55 against US\$1.00 as of March 31, 2005.)

ChipMOS March 2005 consolidated revenue included revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS Far East Limited, ChipMOS Logic TECHNOLOGIES INC., CHANTEK ELECTRONIC CO., LTD., Modern Mind Technology Limited and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., ThaiLin Semiconductor Corp. and FIRST SEMICONDUCTOR TECHNOLOGY, INC.
