**Item 1.01. Entry into a Material Definitive Agreement**

On September 26, 2006, pursuant to the EMC Corporation Executive Incentive Bonus Plan, the Compensation Committee of the EMC Corporation ( EMC ) Board of Directors established the performance goals for Joseph M.
