**Item 8.01. Other Events.**

On February 22, 2007, Fuji Xerox Co., Ltd. ( FX ), an unconsolidated entity of which Registrant owns 25% and FUJIFILM Holdings owns 75%, informed Registrant that it plans to record restructuring charges in its fiscal fourth-quarter 2006 as part of FX 's continued cost-reduction actions to improve productivity and its competitive position. Registrant accounts for its share of FX on an equity basis. While Registrant is reaffirming its full-year 2007 guidance of \$1.12 to \$1.16, it is revising its first-quarter guidance to \$0.18 to \$0.20 to reflect its 25% after-tax share of the FX-related restructuring charge of \$0.03.
