Dear colleague,

I am delighted to share some important news with you. Netherlands-based ABN Amro and Barclays have agreed to merge. The holding company of the combined group will be known as Barclays PLC.

The result of the merger is that we will be joined by more than 90 000 new colleagues. This merger will also create a financial services powerhouse. It will be regarded as the biggest transaction in the history of the financial services industry, creating the world's fifth largest bank.

What does this mean for Absa? A successful merger between ABN Amro and Barclays will create a strong and competitive combination for its customers with superior products and services and an extensive distribution network from which Absa can leverage.

Absa will now become part of this new global player in banking serving 47 million customers of which 90% are in seven key markets. This will result in a new and leading banking platform that offers a world-class payment system and trade finance solutions. Also, Barclays PLC will now become the fifth largest card issuer outside the US with approximately 27 million cards in issue.

The merger will place Absa Capital in a favourable market position as it is envisaged that the merger will see the establishment of a new premier global investment bank with an enhanced product offering across a broad global footprint.

We will also be able to leverage off the emergence of the world's largest institutional asset manager, which will have an enhanced retail distribution capability. In addition, we will be able to offer complementary products to a much larger customer base.

The merger also signals good news for Absa Private Bank as the merger will create the world's eighth largest wealth manager.

I will keep you posted of developments as they unfold. Even with the news of this exciting development, let's not forget to continue in working in the Absa spirit - putting our customers first and performing at a level that keeps us a step ahead of our competitors.
