QVT Financial LP (QVT Financial) is the investment manager QVT Overseas Ltd., which beneficially owns 3,800,616 shares of Common Stock. QVT Financial is also the investment manager for several funds (the Funds), which beneficially own an aggregate amount of 4,027,690 shares of Common Stock, consisting of 768,960 shares of Common Stock owned by Quintessence Fund L.P. (Quintessence), 1,448,290 shares owned by QVT Associates LP and 1,810,440 shares owned by QVT Global II L.P. In addition, QVT Financial is the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account), which holds 920,753 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by QVT Overseas Ltd., each of the Funds and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 8,749,059 shares of Common Stock, consisting of the shares owned by QVT Overseas Ltd. and the Funds and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Funds, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Funds and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 4,027,690 shares of Common Stock.

Each of QVT Financial and QVT Financial GP LLC disclaims beneficial ownership of the shares of Common Stock owned by QVT Overseas Ltd. and the Funds and held in the Separate Account. QVT Associates GP LLC disclaims beneficial ownership of all shares of Common Stock owned by the Funds except to the extent of its pecuniary interest therein.

QVT Overseas Ltd. acquired beneficial ownership of more than 5% of the class of equity securities as of February 4, 2007. The reported share amounts reflect amounts beneficially owned by the reporting persons as of that date.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based upon 70,133,499 shares of Common Stock outstanding, which is the total number of shares issued and outstanding reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2007 and filed with the Securities and Exchange Commission on November 9, 2007.
