**INFORMATION REQUIRED IN REGISTRATION STATEMENT**

**Item 1. Description of Securities to Be Registered.**

The title of the class of securities to be registered hereunder is 8.000% Enhanced Trust Preferred Securities (the Trust Preferred Securities). The Trust Preferred Securities will be issued by KeyCorp Capital X and guaranteed by KeyCorp (KeyCorp) to the extent set forth in the form of guarantee (the Guarantee) and certain other documents of KeyCorp. A description of the Trust Preferred Securities is set forth in the Registration Statement on Form S-3 (File Nos. 333-134937 and 333-134937-04), filed with the Securities and Exchange Commission (the Commission), as thereby amended (as amended, the Registration Statement) and in the Prospectus Supplement relating thereto dated February 20, 2008 and filed with the Commission pursuant to Rule 424(b)(5) under the Securities Act of 1933, as amended (the Securities Act), under the captions KeyCorp Capital X, Description of the Trust Preferred Securities, Description of the Junior Subordinated Debentures and Description of the Guarantee, which descriptions are hereby incorporated by reference herein. Any form of prospectus or prospectus supplement that includes such description that is subsequently filed by the registrants as part of an amendment to the Registration Statement or otherwise pursuant to Rule 424(b) under the Securities Act is hereby incorporated by reference herein.
