**Item 7.01 Regulation FD Disclosure.**

On March 30, 2009, Nexstar Broadcasting, Inc. ( Nexstar Broadcasting ), an indirect subsidiary of Nexstar Broadcasting Group, Inc., today announced the successful completion of its previously announced offer to exchange up to \$143,600,000 aggregate principal amount of its outstanding 7% Senior Subordinated Notes due 2014 (CUSIP No. 65336YAB9) (the Old Notes ) for (i) up to \$142,320,761 in aggregate principal amount of Nexstar Broadcasting s 7% Senior Subordinated PIK Notes due 2014 (the New Notes ), to be guaranteed by each of the existing guarantors to the Old Notes, and (ii) cash. The exchange offer expired at 12:00 midnight, New York City time, on March 26, 2009. A copy of the press release relating to the announcement is furnished as Exhibit 99.1 to this report and is incorporated herein by reference.
