DEREGISTRATION OF SECURITIES

This Post-Effective Amendment No. 1 relates to the Registration Statement on Form S-3 (File No. 333-142611) (the Registration Statement) filed by Markel Corporation (the Registrant) on May 4, 2007, registering 11,790 shares of its common stock, no par value (Common Stock) for sale by selling shareholders, none of whom are affiliates of the Registrant. To date, 5,598 shares of Common Stock have been sold under the Registration Statement. In accordance with the terms of the agreement under which the shares were registered, the Registrant is not required to keep the Registration Statement effective for more than three years after its effective date. Accordingly, in accordance with the undertakings in the Registration Statement to remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering, the Registrant hereby removes from registration all shares of Common Stock registered under the Registration Statement that remain unsold as of the date hereof.
