#### ITEM 2.01 Completion of Acquisition or Disposition of Assets.

As previously reported, on May 24, 2012, MasTec North America, Inc. ( $\underline{\text{MasTec NA}}$ ), a wholly owned subsidiary of MasTec, Inc., a Florida corporation (the  $\underline{\text{Company}}$ ), entered into a Membership Interest Purchase Agreement with the Company's wholly owned subsidiary, DirectStar TV, LLC ( $\underline{\text{DirectStar}}$ ), Red Ventures, LLC ( $\underline{\text{Red Ventures}}$ ) and the other parties thereto, pursuant to which Red Ventures agreed to purchase, and MasTec NA agreed to sell, all of the issued and outstanding membership interests in DirectStar (the  $\underline{\text{Unit}}$ s' and such purchase and sale of the Units, the  $\underline{\text{Transaction}}$ ).

On June 15, 2012, the Transaction was consummated, and Red Ventures paid to the Company the purchase price in an amount in cash equal to approximately \$105.6 million, subject to certain adjustments.
