On March 28, 2014, Nielsen Holdings N.V. (the Company), parent company of The Nielsen Company B.V., announced that its indirect wholly-owned subsidiaries, Nielsen Finance LLC and Nielsen Finance Co., proposed to offer, through a private placement, \$750,000,000 aggregate principal amount of senior notes due 2022, subject to market and other conditions.
