**ITEM 7.01 Regulation FD Disclosure.**

On April 1, 2014, the Centers for Medicare & Medicaid Services (CMS) provided new, updated pricing for the sequencing of the BRCA1 and BRCA2 genes. The new pricing resulted in a total reimbursement amount for Myriad's integrated BRCA*Analysis*<sup>®</sup> of \$2,767. Below is a summary of the change in pricing for the relevant codes:
