On April 10, 2014, Kforce Inc. held its Annual Meeting of Shareholders. As of the record date of February 28, 2014, 33,984,113 shares of Kforce's Common Stock were outstanding and entitled to vote. Of this amount, 31,541,886 shares, representing approximately 92.81% of the total number of shares outstanding and entitled to vote, were represented in person or by proxy constituting a quorum.
