On November 12, 2015, Consolidated Edison Company of New York, Inc. ( CECONY ) entered into an underwriting agreement with J.P. Morgan Securities LLC, Merrill Lynch, Pierce, Fenner & Smith Incorporated, and Wells Fargo Securities, LLC, as representatives of the underwriters named therein, for the sale of \$650 million aggregate principal amount of CECONY 's 4.50% Debentures, Series 2015 A (the Debentures ). The Debentures were registered under the Securities Act of 1933 pursuant to a Registration Statement on Form S-3 (No. 333-206177, effective August 6, 2015).
