On April 11, 2018, CytoDyn Inc., a Delaware corporation (the Company), announced that it has withdrawn its previously announced intention to effect a reverse stock split of its common stock, which was expected to occur on or about April 19, 2018. The Company reserves the right to effect the reverse stock split at any time before August 24, 2018, as previously authorized by its stockholders, if and as determined by its board of directors, upon proper notice to the holders of its equity interests.
