**Statement of SJW CEO Delivered Before the San Jose City Council on June 5, 2018**

My name is Eric Thornburg. I joined San Jose Water 7 months ago as CEO. I've spent my entire 35 year career working in the water profession.

For 152 years, San Jose Water has served the people of this valley with high quality drinking water.

Our employees are proud to live, work, and serve here.

It is clear to me that our employees are incredibly talented and we operate a World Class water utility.

It is also equally clear to me that our customers have deep concerns.

We may not have always seemed to listen. And we may not have always communicated effectively.

I sincerely apologize for that.

And regarding the recent over-billing issue we experienced it has taken a terrible toll. Many of our customers have lost trust in us.

I also sincerely apologize for that.

We stand ready to issue refunds to our customers. But we need CPUC approval. We hope to obtain that soon.

We are committed to regaining our Customers trust.

No quick fixes we have to re-earn it.

It all starts with our commitment to public health, public safety and environmental stewardship.

That commitment has never been stronger in this era of drought and climate change. But we need to do more.

As a start, we will be reaching out to our customers and asking them directly. How are we doing? How can we serve you better? How do we need to change?

We already know that our customers want us to reduce the pressure of increasing water rates.

That is why we recently announced a plan to merge our parent company SJW Group. Our planned merger allows us to achieve greater scale while maintaining a strong local focus.

Scale means improved purchasing power, sharing best practices and elimination of duplicative administrative costs.

These improvements and savings will directly benefit our customers. And no layoffs, No name change, headquarters remains here, with cost savings ultimately to customers.

Cal Water, a competitor who owns many small utilities across the state, is trying to break up our merger while simultaneously launching a hostile takeover of our company. And they have asked you to help.

I would humbly ask you to work with us, your partner of 152 years. Thank you.
