- (1) The reporting person was granted 3,815 shares of Common Stock, issued pursuant to the 2007 RPM International Inc. Restricted Stock Plan.
On July 16, 2007, 40,000 shares of Common Stock issued to the reporting person pursuant to the RPM International Inc. 2002 Performance Accelerated Restricted Stock Plan, as amended (the "Plan") vested. In accordance with the terms of the Plan, the reporting person disposed of 12,380 shares of Common Stock back to the Issuer to satisfy tax obligations of the reporting person.
- (3) Includes an aggregate of 8,702 shares of Common Stock issued pursuant to the 1997 RPM International Inc. Restricted Stock Plan, as amended, 3,815 shares of Common Stock issued pursuant to the 2007 RPM International Inc. Restricted Stock Plan, and 19,000 shares of Common Stock, issued as Performance Earned Restricted Stock, pursuant to the RPM International Inc. 2004 Omnibus Equity and Incentive Plan.
