The reporting person acquired the 3,741 shares pursuant to a merger agreement entered into on January 1, 2008 and placed a value of \$20.11 a share, its closing price on February 28, 2008. The merger agreement provided that the reporting person has 11,225 shares held in (1) escrow and subject to forfeiture during a two year period following the merger to satisfy claims arising as a result of a breach of representations and warranties. An additional 7,484 shares could be issued to the reporting person upon the termination of the escrow agreement if no claims are made.
