5,357 previously owned shares having a market value of \$13.22 per share were delivered in payment of the option price of \$6.81 per share for 10,400 shares acquired pursuant to the exercise of an option granted under the 2002 Performance Plan. In addition, 2,129 shares were withheld to pay Federal withholding taxes as permitted by the 2002 Plan and option grant.

- (2) 10,400 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan. As a result of the transaction reported herein, the reporting person's ownership of stock increased by 2,914 shares.
- (3) Total number of shares of common stock allocated to the account of the reporting person in a Trust established under Goodyear's Employee Savings Plan for Salaried Employees, a 401(k) Plan, as of June 11, 2009 as reported by the Plan Trustee.

- (5) Exercise of Non-Qualified Stock Option granted on 12/2/2003 under the 2002 Plan.
