- (1) Amendment to Form 4 filed on May 20, 2011 reporting the cancellation for value of certain stock options. This amendment is being filed to indicate the transaction code applicable to the cancellation and specify the price per derivative security.
- (2) Partial cancellation of vested options.
- (3) The options being cancelled were part of a grant of 155,172 options on December 6, 2007 that vested in three equal installments on each of the first three anniversaries of the grant date. As of December 6, 2010, all options were vested and exercisable.
- (4) On May 18, 2011, 80,000 options were cancelled by agreement between Mr. Roman Jimenez and the Issuer. Mr. Roman Jimenez received \$511,200 (which is the difference between the exercise price of each option and the price of the Issuer's Class B Common Stock at market close on May 18, 2011 multiplied by the amount of options cancelled) as consideration for the cancellation.
