(the "Company"), granted on each of June 23, 2008, February 9, 2009 and March 23, 2010 pursuant to the Company's 2008 Management Incentive Plan and July 21, 2011 pursuant to the Company's

(1) 2011 Equity Incentive Plan. Pursuant to the terms of the awards, 13,266, 5,166 and 1,000 of the restricted stock units will vest on March 31, 2013, 2014, and 2015 respectively, subject to the Company's satisfaction of certain performance criteria for each of the fiscal years ending December 31, 2012, 2013 and 2014, and further subject to continued employment through the vesting date. The performance criteria for 2011 were met, resulting in the vesting of 17,621 restricted stock units. Any units that do not vest will be forfeited.
