- (1) These restricted stock units were previously granted to the Reporting Person under the NuPathe Inc. 2010 Omnibus Incentive Compensation Plan, subject to the achievement of certain performance criteria. On January 17, 2013, the performance criteria applicable to these restricted stock units was met. As a result, 1/3 of the restricted stock units will vest on January 17, 2014 (the one-year anniversary of the achievement of the performance criteria) with the balance vesting in 8 equal quarterly installments thereafter. Vested shares will be delivered to the Reporting Person on the earliest of: (i) March 31 of the calendar year immediately following the year in which the restricted stock unit vests, (ii) a change of control of the Issuer or (iii) the Reporting Person's separation from service with the Issuer.
