- (1) Represents earn-out of previously awarded performance units granted in January 2012.

Each performance unit represents a contingent right to receive one share of the company's common stock. 2,423 performance units vested and 5,741 performance units were forfeited on January 7, 2014, based on the company's total stockholder return performance relative to a selected peer group for the two years ended December 31, 2013. The remaining performance units vest in January 2015 based on the company's total stockholder return performance relative to a selected peer group for the three years ended December 31, 2014. The performance units reported represent target performance.
