- (1) Restricted Stock with Performance Based Vesting awarded to Reporting Person on 08/07/2014 - 25,000 shares of the Restricted Stock shall become eligible to vest if prior to July 1, 2017, upon Issuer's common stock achieving an average closing price of \$25.00 per share for 20 consecutive trading days and 25,000 shares of the Restricted Stock shall become eligible to vest (collectively, the "Eligible Shares") if prior to July 1, 2017, upon Issuer's common stock achieving an average closing price of \$30.00 per share for 20 consecutive trading days. Eligible Shares shall vest in equal quarterly installments over the following year; provided however, that all Eligible Shares shall be fully vested on July 1, 2017, or upon a Change in Control, Death or Disability.
