Each share is represented by a restricted stock unit (RSU). Each RSU represents a contingent right to receive one share of the Issuer's existing Class B Common Stock ("Existing Class B Common Stock") upon settlement. Each share of Existing Class B Common Stock is

- (1) convertible into one share of the Issuer's existing Class A Common Stock ("Existing Class A Common Stock") upon the election of the Issuer and has no expiration date. 1,125 of the RSUs vest on March 20, 2015, and 1/8 of the remaining RSUs vest every three months thereafter.
- (2) Each share of Existing Class B Common Stock is convertible into one share of Existing Class A Common Stock upon the election of the Issuer and has no expiration date.
- (3) 1/36 of the shares subject to the option vested on May 3, 2014, and 1/36 of the shares vest monthly thereafter.
