The price reported in Column 4 of Table 1 on Lines 2, 4 and 6 with respect to the shares sold on August 20, 2014 is a weighted average price. These shares are owned directly by Huntsman Family Holdings Company LLC and indirectly by other members of Huntsman Family Holdings Company LLC and the reporting person. The reporting person disclaims beneficial ownership of the shares held by Huntsman Family Holdings Company LLC, except to the extent of his pecuniary interest therein, and the inclusion of these shares in this report shall not be deemed an admission of beneficial ownership of all of the reported shares for purposes of Section 16 or for any other purpose.

This option vested as to 10,483 shares on February 1, 2013, 10,482 shares on February 1, 2014 and will vest with respect to the remaining 10,482 shares on February 1, 2015.

This option vested as to 8,418 shares on February 6, 2014 and will vest with respect to 8,417 shares on February 6, 2015 and 8,418 shares on February 6, 2016.
