(3) The reporting person elected to defer receipt of 360 shares of common stock issuable upon the exercise of his options, resulting in the accrual to his account of 8280 shares of phantom stock of which 7920 of those shares were used to pay for the exercise price. The stock expires upon the termination of the Deferred Compensation Agreement which remains in effect until the reporting persons retirement or the agreement is otherwise terminated.

(4) The reporting person elected to defer receipt of 640 shares of common stock issuable upon the exercise of his options, resulting in the accrual to his account of 8039 shares of phantom stock of which 7399 of those shares were used to pay for the exercise price.
