**ITEM 1. SECURITY AND ISSUER.**

This Statement on Schedule 13D relates to the common stock, par value \$0.001 per share (the "Shares"), of GroveWare Technologies Ltd., a Nevada Corporation (the "Issuer"), and is being filed by Hrair Achkarian (the "Reporting Person"). The Issuer's current principal executive offices are located at 1006 - 20 Eglinton Ave. W Toronto, Ontario Canada M4R 1K8.

**ITEM 2. IDENTITY AND BACKGROUND**

(a) through (c) and (f). This Statement is being filed by Hrair Achkarian (the "Reporting Person"). The business address of the Reporting Person is 1006 - 20 Eglinton Ave. W Toronto, Ontario Canada M4R 1K8. Hrair Achkarian is currently the President, CEO and Director of GroveWare Technologies Ltd.

(d) and (e). During the previous five (5) years, the Reporting Person (i) has not been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors) and (ii) has not been party to a civil proceeding of any of a judicial or administrative body of competent jurisdiction such that, as a result of such proceeding, was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activity subject to, federal or state securities laws or finding any violation with respect to such laws.

**ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.**

The Shares to which this statement relates were purchased by Hrair Achkarian with his personal funds.

**ITEM 4. PURPOSE OF TRANSACTION**

The purpose of this Schedule 13D is to report the Beneficial Ownership by the Reporting Person of 200,000,000 shares or 65% of the Issuer's issued and outstanding common stock as of July 12, 2012.

Except as provided below, the Reporting Person does not have any current plans or proposals which would relate to or would result in:
