(1) On December 30, 2014 the Issuer entered into a Debt Conversion Agreement with Mr. Howlett totaling \$34,092.30. Under the terms of the Debt Conversion Agreement, Mr. Howlett has the right to convert the debt amount into common stock of the Issuer as well as a warrant agreement to purchase one share for every two shares acquired. The expiration date on the warrant is 3 years from the date of conversion.
