## Fund Raising

(Rio de Janeiro, December 4, 2008). PETRÓLEO BRASILEIRO S/A - PETROBRAS, [Bovespa: PETR3/PETR4, NYSE: PBR/PBRA, Latibex: XPBR/XPBRA, BCBA: APBR/APBRA], a Brazilian international energy company, announces that in the ordinary course of its business, it has been raising funds in the national and international financial market aiming to maintain the company strength and to undertake its investment program as announced.

- In addition to the funds raised through the end of October, as widely announced in the Quarterly Information Report (ITR) under the subsequent event item, we undertook the following operations:
- \$200 million contracted on November 7, 2008 with a pool of foreign banks lead by the BNP Paribas bank, and insured by the Italian exports credit agency SACE (Servizi Assicurativi del Commercio Estero), with a 14-year term.
- \$500 million contracted on December 1, 2008 with Canadian export credit agency EDC (Export Development Canada), with a 12-year term.
- \$200 million with Bradesco, on December 3, 2008 as a Pre-Shipment Export Financing (ACC) and due in 01 year.

The 2008-2012 Business Plan projects investments of \$112.4 billion, which will be financed via the company's own cash generation and with funds raised in the market. The financing activity is part of the Company's cash management activities and is regularly released in its Financial Reports.
