**SÃO PAULO, JUNE 21, 2012 – GOL Linhas Aéreas Inteligentes S.A. (BM&FBovespa: GOLL4 and NYSE: GOL), (S&P: B+, Fitch: B+, Moody's: B3), the largest low-fare, low-cost airline in Latin America, and Qatar Airways, the Qatar state airline, announce the beginning of a Frequent Flyer agreement, enabling participants of GOL SMILES and Qatar Airways' Privilege Club loyalty programs to accumulate miles on all flights operated by the two groups. It will also be possible to redeem tickets shortly.**

"We are very pleased to expand our partnership with Qatar Airways, one of the most renowned international airlines. In addition to augmenting movement through our system, the agreement will allow us to offer our SMILES clients direct access to the Middle East and Asia, extending the reach of the program, which already has partners in North America and Europe, even further," declared Constantino de Oliveira Junior, CEO of GOL.

The two airlines have maintained a codeshare agreement since 2011, through which Qatar Airways can add its code (QR) to GOL flights from São Paulo to 48 domestic destinations. Additionally, Qatar Airways, which operates in Brazil through direct flights between Doha, the capital of Qatar, and São Paulo, has the possibility of distributing its clients throughout GOL's entire route network, one of the largest in the continent, with multiple connection options. For GOL, the agreement represents an efficient additional sales channel which will help increase passenger flow and push up the load factor on its own flights.
