“The Grupo GWI, of which GWI Asset Management S.A., a corporation headquartered in the City and State of São Paulo at Av. Brigadeiro Faria Lima, nº 3900, 6º andar, conj. 602, is a part of, pursuant to CVM Instruction No. 358/2002, amended by CVM Instruction No. 449/07, hereby announces that it now holds, jointly, a total of twenty-one million, nine hundred thirty-eight thousand, nine hundred ninety-six (21,938,996) common shares, equivalent to 50.17% of all common shares issued by the Company.

As this exceeds 50% of all shares issued by the Company, GWI will take all measures established in the Corporate Bylaws, in compliance with the Brazilian Corporation Law, the regulations of the Securities and Exchange Commission of Brazil (CVM), and the regulations of the Stock Exchanges where securities issued by the Company are traded.
