In a media interview on August 24, 2010, Jaya Kumar, President of Quaker Foods and Snacks, stated the company spends "about \$75 to \$100 million" in research and development (R&D) in the United States. The \$75 to \$100 million in R&D spending that Mr. Kumar referred to relates to all of PepsiCo's foods businesses in North America, which include Quaker Foods North America and Frito-Lay North America.
