On March 30, 2016, PepsiCo, Inc. ("PepsiCo") announced a series of senior executive changes, including the promotion of Albert P. Carey to Chief Executive Officer, North America, overseeing North America Beverages, Frito-Lay North America and Quaker Foods North America. Mr. Carey previously served as Chief Executive Officer, North America Beverages. On March 27, 2016, Thomas R. Greco, Chief Executive Officer, Frito-Lay North America, notified PepsiCo of his decision to resign from PepsiCo, effective April 8, 2016, to pursue an opportunity at another company.
