## Explanation of Responses:

The shares of common stock of Apache are deemed to also represent certain preferred stock purchase rights ('Rights'). The Rights are not currently exercisable or separately tradable and presently are evidenced by certificates for shares of the common stock. Value attributable to such Rights, if any, is reflected in the market price of the common stock.

- (1) Vesting on 02/11/2013 of restricted stock units pursuant to restricted stock unit award agreement under employer plan. Of these 12,500 shares, 7,500 shares (5,391 shares after tax withholding) will not be eligible for sale by the reporting person until such time as he retires or otherwise terminates employment with the company.
- (2) Shares withheld to cover required tax withholding on vesting of restricted stock units effective as of 02/11/2013.
- (3) These shares are held in trust for the benefit of the reporting person's children. The reporting person and spouse are trustees.
- (4) With tandem tax withholding right
- (5) One share of Apache common stock for each restricted stock unit.
