(4) Includes (i) 3,250 unvested restricted stock units of which the last installment will vest on December 14, 2014 and is associated with a December 14, 2010 grant; (ii) 6,250 unvested restricted stock units of which the last installment will vest on May 10, 2015 and is associated with a May 10, 2011 grant; (iii) 13,500 unvested restricted stock units which will vest in equal installments on January 1st over the next two years and is associated with a February 14, 2012 grant; (iv) 28,500 unvested restricted stock units which will vest in equal installments on January 1st over the next three years and is associated with a January 18, 2013 grant; and (v) 25,000 unvested restricted stock units which will vest in equal installments on over the next two years on January 1st of each year, with a final lapse date of January 1, 2016 and is associated with a February 11, 2014 grant.
