On November 21, 2014, H. Paulett Eberhart was elected as a director of LPL Financial Holdings Inc. (the “Company”) and as a member of the audit committee of the board of directors of the Company (the “Board”).

The Board has determined that Ms. Eberhart is independent under applicable standards of the Nasdaq Stock Market and Securities and Exchange Commission and is an “audit committee financial expert” as defined under Item 407 of Regulation S-K.

Pursuant to the Company’s non-employee director compensation policy, Ms. Eberhart was granted 1,410 restricted shares of the Company’s common stock on November 21, 2014. The restricted shares are scheduled to vest in full on November 21, 2016.
