- (4) United Natural Foods, Inc.'s closing price on the NASDAQ National Market on September 10, 2010.
- (5) The stock options vest and becomes exercisable in four equal annual installments beginning on the first anniversary of the date of grant.
- (6) On September 11, 2010, 2,994 shares of United Natural Foods, Inc. (the "Company") restricted stock units vested. The Company retained 931 shares on September 11, 2010 to satisfy certain tax withholding obligations in connection with the vesting of such shares.
