- Ms. Bonstein's employment agreement entitles her to a year end cash bonus. Ms. Bonstein voluntarily requested to be paid a portion of her cash bonus in common stock of the registrant instead of cash. The company agreed to Ms. Bonstein's request and she was therefore granted 22,595 shares of the registrant's common stock in lieu of a cash bonus payable to Ms. Bonstein. Such grant was made upon approval of the registrant's compensation committee and agreement of executive. All of such shares vested immediately.
