(1) The reporting person received a grant of 13,810 restricted common units of Oiltanking Partners, L.P. on July 14, 2014. (2) The amount of securities beneficially owned following the reported transaction has been adjusted to reflect a two-for-one split of the common units of Oiltanking Partners, L.P. that became effective on July 14, 2014. The 2,386 common units held by the reporting person prior to July 14, 2014 were adjusted to reflect the split, resulting in the reporting person's ownership of an additional 2,386 common units.
