<b>Observation Dates</b>	Approximately one year, two years, three years and four years from the pricing date
<b>Call Amount</b>	[\$11.00 to \$11.10] if called on the first Observation Date, [\$12.00 to \$12.20] if called on the second Observation Date, [\$13.00 to \$13.30] if called on the third Observation Date and [\$14.00 to \$14.40] if called on the final Observation Date, each to be determined on the pricing date
