(SSFQP), Special Situations Private Equity Fund, L.P. (SSPE and together with (2) CAYMAN and SSFQP, the Funds). As the investment adviser to the Funds, AWM holds sole voting and investment power over 376,545 Shares of common stock of the Issuer (the Shares) held by CAYMAN, 1,081,707 Shares held by SSFQP and 376,543 Shares held by SSPE.
  - (3) Austin W. Marx (Marx), David M. Greenhouse (Greenhouse) and Adam C. Stettner (Stettner) are the controlling principals of AWM. The reporting person disclaims beneficial ownership of the Shares, except to the extent of its pecuniary interest therein. This report shall
