# Item 1.01 Entry into a Material Definitive Agreement Underwriting Agreement

On March 22, 2016, The Michaels Companies, Inc. (the "Company") entered into an underwriting agreement (the "Underwriting Agreement") with J.P. Morgan Securities LLC and Merrill Lynch, Pierce, Fenner & Smith Incorporated (the "Underwriters") and the selling stockholders listed on Schedule 2 thereto (the "Selling Stockholders"), relating to the underwritten offering of 17,000,000 shares (the "Shares") of the Company's common stock, par value \$0.067751 per share (the "Offering"). All of the Shares are being sold by the Selling Stockholders. The Underwriters have agreed to purchase the Shares from the Selling Stockholders pursuant to the Underwriting Agreement at a price of \$26.08 per share.

In addition, pursuant to the Underwriting Agreement and in accordance with the Company's ongoing share-repurchase program, the Company has agreed to purchase from the Underwriters 2,000,000 shares of common stock being sold by the Selling Stockholders to the Underwriters, at the per share price being paid by the Underwriters to the Selling Stockholders, resulting in an aggregate purchase price of \$52,160,000 (the "Share Repurchase"). The Company intends to fund the Share Repurchase with cash on hand.

The Offering is being made only by means of a prospectus. An automatic shelf registration statement (including a prospectus) relating to the offering of common stock was filed with the Securities and Exchange Commission (the "SEC") on July 9, 2015, and became effective upon filing (Registration No. 333-205583) (the "Registration Statement"). A prospectus supplement relating to the Offering has been filed with the SEC. The closing of the Offering and the Share Repurchase is expected to take place on March 29, 2016, subject to the satisfaction of customary closing conditions. A copy of the Underwriting Agreement is filed as Exhibit 1.1 to this Current Report on Form 8-K.
