On January 2, 2019, the Issuer entered into an agreement with Kevin J. Bannon (the "Reporting Person") whereby the Reporting Person (1) was granted a restricted stock award of 1,200 shares of Class A Common Stock that vests on January 2, 2024, pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").

The Reporting Person is the indirect beneficial owner of 1,000 shares of Class A Common Stock, which are owned by the Trust (3) established under the will of Nathan B. Epstein for the benefit of Susan E. Bannon, Mr. Bannon's wife, et ano. Mr. Bannon is co-trustee of the trust.
